f. Breakfast Program

Scott Smith presented a proposed, self-funded, pilot breakfast program for Coffin and Jordan Acres Schools to begin in mid May. Next year all schools would offer breakfast.

h. Budget Update - Mr. Oikle

Mr. Oikle reported that the current fiscal year finances are in good order, and the year should end in the black. He said that a group is looking into applying for a grant for a garden at Harriet Beecher Stowe School.

Mr. Bartlett reported on the active shooter and evacuation drill held on April 13, and despite a few oversights, the operation went smoothly.

Mrs. Perreault announced that a public forum on the proposed school budget will be held on April 27 at 7:00 p.m.

b. May 4 Special Meeting Topic

Mrs. Perreault said there will be a vote on the school budget on May 4 at 6:00 p.m.

c. Introduction and Report from the Student Liaison

Julia Brown thanked the Board for voting to have a student liaison. She said she will represent all students in grade K-12, and from time to time she will give a school report. A representative from the high school student government will continue to give reports also.

Committee Reports

a. Policy and Planning Committee - Ms. Small

Ms. Small explained an amendment to policy IJJ.

b. Curriculum and Program Development - Mr. Corey

Mr. Corey reported the committee discussed new report cards and the use of rubrics for assessment. There are plans to review the K-8 science and physics curriculum.

c. Maine Region 10 Tech Cooperative Board - Mrs. Connors

Mrs. Connors reported that the Board discussed retirement incentives, budget details, enrollment numbers, full-day schedules, a student interest survey, and the National Technical Honor Society.

d. Student Services - Mr. Perzanoski

Mr. Perzanoski said that the committee discussed the pre-school program now on hold. Future items for discussion are transportation and sports.

e. Political Action and Media - Mr. Grant

Mr. Grant said a committee member was appointed to the Cable TV Committee, and the committee heard a proposal from high school teacher John Riggleman about a community collaboration project. Mr. Grant passed out a draft resolution for Board perusal outlining opposition to the governor's Maine State Retirement System proposal.

Mr. Grant moved, with a second by Ms. Small, to approve the resolution as presented.

Ms. Small moved, with a second by Mrs. Connors, to amend the resolution by removing the retirement age section. The vote was unanimous of the Board members present to approve the amendment.

The final vote was 6-1-1 (Grant opposed; Corey abstained) to approve the resolution as amended.

f. Facilities and Maintenance – Mr. Ellis

Mr. Ellis said the committee took a site walk at the former Times Record building on Industry Road.

g. Budget and Finance - Mrs. Connors

Mrs. Connors said the committee had an orientation about the budget process from Mr. Oikle and Mr. Perzanoski.

h. Personnel and Negotiations - Mrs. Perreault

Mrs. Perreault said the committee will begin teacher negotiations.

42. Discussion of Budget Proposals

The Superintendent announced that high school bussing will be re-instated in the proposed budget. He outlined several cuts to help achieve this. He said he hopes to hear about new health insurance rates very soon.

43. Consideration of Changing School Start and End Times

Mr. Worth made a presentation on two proposals of start and end times for schools in the fall.

Mr. Corey moved, with a second by Mr. Grant, to approve modified scenario #2.

Mr. Grant moved, with a second by Mr. Ellis, to amend the Coffin School start time from 9:10 a.m. to 9:00 a.m. The vote was 6-2 (Corey, Perreault opposed). The amendment passed.
