



## **School Closure - Critical Care Workers Information**

In accordance with Executive Order 20-19 issued by Governor Walz, the District will provide childcare services for children **ages 12 and under** of critical care workers. **The care for children of these workers is intended for extreme circumstances in which no parent or guardian is available to care for a child due to employment as a critical worker.**

Our schools will provide childcare for eligible children of critical care workers from 7:30 am to 6:00 pm. A critical care worker includes:

### **Tier 1**

- ☐ Health care and public health
- ☐ Law enforcement, public safety and first responders
- ☐ Food and agriculture
- ☐ Judicial Branch (essential services)
- ☐ National Guard
- ☐ Educators and school staff providing care for critical workers in Tier 1 and Tier 2
- ☐ Childcare providers caring for children of any critical worker in the Governor's Executive Order
