Overview Of The Seven Models

Models	Description
Model 1	Patrick Henry & Jefferson-Houston remain PreK/K-8s, with improvements
Model 2	Patrick Henry & Jefferson-Houston become PreK/K-5s; 6-8 students go to George Washington or Francis C. Hammond
Model 3	Patrick Henry & Jefferson-Houston become PreK/K-5s; a new middle school is opened at 1703 Beauregard St.
Model 4	Patrick Henry & Jefferson-Houston become middle schools; their K-5 students go to existing K-5 schools
Model 5	One PreK/K-8 becomes a 6-8 middle school, the other a K-5 elementary school
Model 6	Patrick Henry & Jefferson-Houston remain PreK/K-8s, an additional school to be identified to become a K-8 school, 1703 Beauregard St. becomes a new middle school
Model 7	Patrick Henry & Jefferson-Houston remain PreK/K-8s, an additional school to be identified to become a K-8 school, a new middle school is proposed/constructed, and 1703 Beauregard St. becomes available to expand K-5 capacity

K-8 Cost Analysis Comparing Model 2 and 5 to Model 1 (Initial Projections)

- If both schools became elementary schools the division would save an estimated \$5.5M versus operating them as K-8s (This would increase the capacity utilization of GW and FCH) (Model 2).
- If Patrick Henry became a middle school and Jefferson Houston an elementary school the division would save an estimated \$5.3M versus operating them as a K-8s (Model 5).
- If Jefferson Houston became a middle school and Patrick Henry an elementary school the division would save an estimated \$5.8M versus operating them as K-8s (Model 5).

Patrick Henry conversion into E.S. will bring capacity utilization approx. between 94% to 96%










Redistricting will address middle and elementary school capacity changes

Impact on CIP- Newly Constructed Middle School

- High Initial Cost: A significant budget impact with an average estimated cost of \$130 million, straining existing CIP funds.
- Funding Sources: Need to identify potential funding sources, including bonds, grants, or reallocating funds from other projects.
- **Long-Term Financial Commitment**: Increased operational costs, including staffing, maintenance, and utilities for the new facility.
- **Potential for Cost Overruns**: Large projects often exceed initial estimates due to inflation, supply chain issues, or unforeseen expenses.
- **Impact on Other Projects**: Potential delays or reductions in funding for other critical infrastructure projects within the CIP.
- Community Expectations: Increased public demand for quality facilities may require additional investments in enhancements beyond the initial budget.
- Lack of Available Land: Space for fields and outdoor space is a priority for Middle Schools. None of the allocated land for ACPS would be suitable for a Middle School.











Impact on CIP-1703 Conversion to Middle School

- Limited Utilization Improvement: Conversion may not effectively address overall middle school capacity and utilization issues in the division
- **Renovation Costs**: Additional costs associated with retrofitting the existing building to meet middle school standards, which may be significant.
- **Operational Budget Strain**: Ongoing operational costs for a converted facility that may not alleviate overutilization in other middle schools.
- **Short-Term Solution**: May be viewed as a temporary fix rather than a sustainable solution for middle school needs in the area.
- Future Budget Planning: Need to plan for future middle school capacity issues that remain unaddressed, potentially leading to further expenditures down the line.
- Site Challenges: 1703 N. Beauregard does not have a field or readily available alternative space for Middle School recreation

Facilities and Operations Next Steps: Rationale for Capacity Recommendations

Timing of Conversions

- → The increase of capacity from George Mason will help support any distribution of students from K-8 schools during construction.
- → There is limited CIP budget availability FY2026-FY2029.
 - Middle School conversions timed from FY 2030 to FY 2032 permits continuity with City Guidance on CIP Budget

Explanation of School Reconfiguration Recommendation

- → Jefferson-Houston is able to add capacity for an 850 student middle school.
- → Patrick Henry can provide K-5 capacity in western Alexandria.
- → Patrick Henry would require more students to be relocated if it was selected for a Middle School.
