A+ Program

To be eligible for the A+ tuition benefit, students must complete the following:

•Attend an A+ designated school for three consecutive years prior to graduation.

- •Graduate with a minimum cumulative GPA of 2.5 on a 4.0 scale.
- •Graduate with a cumulative minimum 95% ADA (Average Daily Attendance).
- •Perform 50 hours of unpaid tutoring or mentoring to other students in the district.
- •Maintain a record of good citizenship and avoid the unlawful use of drugs and/or alcohol.

Students can live the Job Corp college style campus while working on their education and job training. The program helps at risk youth who are between the ages of 16 and 24 who are at poverty levels. Additionally Job Corp can help young adults obtain their High School Diploma or GED and provide job training at the same time. After completion of the program, the students will have a job training certificate and will also have job placement assistance. While in the program they receive free housing, meals, uniforms and basic medical, dental and vision coverage. We also have one location in our region that helps single mothers with children. This location allows mothers to live on campus with their child and take part in our education and job training opportunities. The children must still be of daycare age and not in school. SCHOLARSHIP/ FINANCIAL AID INFORMATION

Seniors need to be aware of three types of scholarships:

- College/University sponsored scholarships—most of these types of scholarships are available on the website of each individual school; most have deadlines on or near December 2015, which means you need to have submitted your application for admission and most likely be admitted in order to be eligible for college/university sponsored scholarships.
- 2. Local Scholarships—these scholarships come through Mrs. Smith and will be posted on the school website as their specific information becomes available. Check the website often, especially beginning in December 2015.
- Sheldon Scholarships—. All students who have post-secondary plans and have applied to a school, are eligible to apply for these scholarships. Students will complete one application that will be due April 1st to be eligible for these scholarships. Please see Mrs. Metcalf or Mrs. Smith for more information.
- 4. FAFSA Monte Padgett, Director of the Nevada Crowder College Campus, will help ANY student and their family, regardless of whether or not the student will attend Crowder College, with the FAFSA process. An appointment is required. Call 417- 667-0518 to schedule an appointment.
