The Executive Membership heard a report or acted upon the following:

- **President's Report**
 - **Student Payments**
 - There are still many unpaid band fees. Mr. Foster will be reminding these students with 1st and 2nd outstanding fees by mail and email and informing of consequences for not paying
 - 4 late scholarships were denied due to late application, lack of funds available, and ineligibility
 - **August Minutes:** Approved, Heather motioned, Mary 2nd
- **Treasurer**
 - **Budget:** will need to be discussed and voted on before 2018.
- **IPE**
 - Costs and payment schedule need to go out as early as possible so families can prepare
 - Fees for IPE will be collected by the school, NOT the boosters
 - An "interest" meeting may be held to get an idea of how many kids will be performing. Grades were a problem last season so maintaining proper GPA will need to be stressed.
- **Guard Uniforms**
 - No Update on when they will be ready. Orders were hand delivered in May. Hoping someone can apply a little pressure to get at least a date when they hope to have them ready.
- **Fundraisers**
 - **Tag Day:**
 - \$3300 was collected, original budget was for \$12000 and included Calendar sales.
 - 43 Students participated and were divided into 11 groups
 - Scheduling a 2nd tag day on October 21st to visit the neighborhoods missed. There are 25 new maps added.
 - There will be a note to leave in the door if nobody is at home

- Thinking of doing a longer time frame and promoting at concerts.
- **Calendar sales:** 120 calendars remain. Hoping to sell some at the invitational. If all are sold, profit will be \$3200
- **Spirit Wear Sales**
 - Currently 205 Items have been sold for a total profit of \$1025. \$410 will go to the booster account at \$615 to student seller accounts. All orders to be in by September 25th.
- **Pit Dad Report:**
 - Golf Cart: new batteries needed. 6-8 batteries are needed at \$125 apiece. Last batteries lasted around 9 years. Need someone to ask Lions for a donation.
 - Props are 90% finished
- **New Business:**
 - Need a Nomination for Trustee to replace John.
