AGREEMENT TO HOLD HARMLESS AND INDEMNIFY

We softball camp participants hereby covenant and agree that, with respect to our use of the premises Montrose High School Softball Field (describe premises) for the purpose of softball camp, during the period June 5, 6, and 7, 2013 (list inclusive dates), to defend, indemnify and hold harmless, The Montrose R-XIV School District, its board members, administrators, teachers, employees, volunteers and agents from and against any and all liabilities, claims, damages, penalties, actions, suits, losses, costs and expenses arising out of or in connection with the use of said premises.

This agreement to defend, indemnify and hold harmless specifically includes all claims arising out of any accident or other occurrence on or about said premises causing injury to any person or property.

We also agree not to allow entrance to the premises or use of the premises by anyone who has not previously been authorized entrance or use of the premises, and who has not previously agreed to protect, defend, indemnify and hold harmless, The Montrose R-XIV School District, its board members, administrators, teachers, employees, volunteers and agents, and whose signatures do not appear on this agreement.

We hereby acknowledge that we have inspected the premises and find the premises fit for our intended use. We also agree to notify The Superintendent or designee of any damages or hazardous conditions immediately, and to immediately discontinue use of the premises, until the condition can be corrected. We hereby acknowledge that the School District does not carry medical pay coverage on the premises referenced herein.
