Tax levies certified to the Dewey County Auditor will be as follows (based on current total valuations): General Fund: AG \$1.197 per \$1,000; Owner-Occupied \$2.679 per \$1,000; Other/Utility/ Commercial \$5.544 per \$1,000 and Special Education: \$1.488 per \$1,000.
