Dear Chambers Parents and Guardians,

Students in yearlong courses will take their final exams on May 24-27, 2022.

Besides teacher-made exams, there are state-mandated, secure classroom assessments provided to measure what students know and are able to do after completing a course.

End-of-Course exams (EOCs) are required for all students currently enrolled in Math I/OCS Math I, English II/OCS English II, and Biology/OCS Biology and Math III. According to State Board of Education policy, students who are enrolled for credit in a course in which an EOC assessment is required shall take the appropriate EOC assessment at the completion of the course.

CTE also offers state-mandated exams for the following courses: Marketing Applications, PLTW Principles of Engineering, Principles of Business, PLTW Intro to Engineering, PLTW Civil Engineering and Architecture, PLTW Medical Intervention, PLTW Human Body System, Business Law, Business Management I, Career Management, PLTW Principles of Biomedical Science

Please be aware of three very important policies in effect for final exams:

- 1. There are no retests, so it is extremely important that students come to school on time, ready to do well on their exams on the assigned days.
- 2. There is a state policy in effect concerning electronics during the administration of NC End-of-Course exam and CTE exams. Under no circumstances can students be seen with an electronic device, including cell phones, iPods, games, and headphones. According to the policy, if a student is seen with a cell phone or other electronic device while testing, during the breaks, or even during a trip to the restroom, that student will be removed from the testing session, and a misadministration will be declared. Therefore, parents, it is extremely important for you to encourage your child to leave devices at home during exams.
- 3. All final exams will count as 20% of a student's final semester grade.

<u>Please Note:</u> Monday, June 6, 2022 is a holiday and there will be no school-wide testing. This will be a regular school day and students will be able to finish missed assignments or teacher made tests.
