



Bloomington Drivers Education Program/A+ Driving School Summer 2022

Bloomington Driver's Education/A+ Driving School will be offering eight classroom/behind-the-wheel packages this Summer for students who are **not signed up to take it as a credit during their regular school day schedule.** High school credits are **not** earned for these driver's education classes.

The total cost is \$420.00 for the classroom & behind-the-wheel package. An \$80 registration fee is due when enrolling. Students may enroll if they are 14-1/2 years of age. To pass the classroom portion, students must attend all 30 hours of classroom instruction. The student will be given information about registering for the 6 hours of Behind-the-Wheel training with A+ Driving School, and will need to pay \$85 to them to receive their blue card. Once the student receives their blue card, they may take their state permit exam at a DVS exam station (**you must schedule an appointment**--locally: Eagan and Chaska). The remainder of the payments to A+ Driving School will be paid at the time of the three Behind-the-Wheel lessons (\$85 per lesson).

*Bloomington Public Schools uses a service called Advantage Collections to recover any checks written to the District for insufficient funds and other reasons, and returned to the District.
