1 Go to [www.thinglink.com](http://www.thinglink.com)

2. Create an account using your school email and a password.

3. Create your interactive photograph by following the steps below...

- Find a photograph about your case online and save it to your H: drive. I would suggest using Google images. Type your court case into the search bar.
- Click on "create" once you have logged into thinglink, and upload your photograph.
- You will insert FIVE tags into your photograph. They must include the following tags:

**-Case background.** You may link to a Wikipedia entry or use a different outside website that seems trustworthy. In your description, **DO NOT COPY AND PASTE** just include your court case name and the sections you want the viewer to read. See my Marbury v. Madison sample.

**-Video clip about the case.** Find a video that explains the case, link to the video in your tag, and include a brief description of the clip in your own words. (Suggested sites to look at: youtube, historychannel, American Memory project, CBS, ABC, CNN, etc.)

**-Significance of decision.** Find a link that sums up why this case is significant. Use Google and type significance of your case in the search bar. In your description, just type in "significance." See my sample.

**-Relevant Vocabulary.** Define at least one word relative to your case. Use a link to dictionary.com or other site to explain the term or definition. See my sample.

**-Political cartoon.** Find a political cartoon online that features your case, link to it in your tag, and then answer, "How does this cartoon relate to your case?" (Suggested sites: Google Image Search) See my sample.
