

Law II-Teen Labor Laws



Teenagers are eager to earn money for clothes, cars, gas, movies, and music. Most students are not aware of the laws concerning the totals hours they can work, safety regulations, or minimum wage laws. You are going to research laws that apply to working teens and answer a questionnaire. Next, you will use the information from the questionnaire to create a brochure that will be given to the front office and handed out to students when they apply for a work permit.

2. Create a two-sided tri-fold brochure informing fellow students about teen labor laws. This brochure will be given to students who ask for a work permit in the office. Include the details from the state web site. The brochure should include pictures, graphics, a table illustrating work times and total hours, and bullet points. Do not include paragraphs of information, it will not be read. Please see the attached rubric for points. Research the history of child labor and why laws are important. Emphasize the importance of education and finding a balance between work and school
