

The Daily Muckraker- 2019 Edition



Purpose: To research the significance of the actions taken by the government and by average American citizens during the Progressive Era. Then we must evaluate whether or not the time period (1901-1920) deserves its name.

Due Date: March 6th – Individual Paper March 8th- Group's "Front Page"

Context: You are all journalists writing for the nationally distributed newspaper called "The Daily Muckraker". The year is 1920 and some of our political leaders have been referring to the previous score as the Progressive Era. Your editor has assigned all of you to the case to research the domestic changes of the last twenty (20) years and to determine whether or not the politicians have a point.

Tasks: Choose a category and describe the leaders and the changes that have taken place.

- Write a newspaper article or an editorial on your category (Approximately 500 words) – **30 points**- see questions below
- Find or create a visual and a headline for your article. **10 points**
- Use a quote from a historical figure in your article. **5 points**
- A document that your article refers to but is not necessarily based upon. **5 points**

Questions to Address in the Article

- What did the person, government action, event do?
- How did it address a social, economic and/or political problem?
- **How did the topic of your article improve the United States?**
- What would critics say about your topic?– You can't make everyone happy ☹
- Relate your topic to another Progressive Era event

Project must also include

- Create a front page to present to the class (Main Headline, 3 stories with headlines, 2 images, "what's inside")- Groups of (5-7 students)-**10 points**
