

Dedicated to meeting the needs of our most at-visk population, the purpose of the Migrant Education Program is to ensure that all migrant students reach challenging academic standards and graduate with a high school diploma (or complete a GED) that prepares them for responsible citizenship, further learning and productive employment. Migrant students are children who move from one school district to another plane or with family members to engage in a migratory agricultural work (including fishing and forestry).



## **Dare to Dream Health Sciences Academy**

### **Eligibility:** Migratory Student\* in Grades 11-12, School Year 2022-23

### A Migratory student must meet these requirements\*:

- A 3.2 or higher GPA OR demonstrate the ability to be academically successful.
  Taken at least one (1) advance course in biology, chemistry, math, etc.
  Plans to pursue a post-secondary education.
  Has an interest in pursuing a career in the health sciences.

## Timeline

- Universities to establish dates for each academy (Nov/Dec '21)
- OSPI with MSDRS releases number of eligible students by district to register (January)
- Registration forms released from February March 2022
- Registration deadline is due March 2022
- Confirmation information sent to students/schools April 2022
- Bus routes and other university information provided by universities May 2022
- Registration cancellations and replacements deadline is two-weeks prior to start of each academy.
- Bus routes and bus capacity may limit replacement counts.










# **Voices from the Field Science Academy June 21-25, 2022**

## Partnership with Islandwood, Bainbridge Island

- Up to 100 students (may be less with COVID-19 guidance)
- Invitation to 10 to 12 districts to send 8-10 migratory students grades 6, 7, and 8.
- Notices to be sent February/March
- Priority for Service migratory students.
- District to provide:
  - Chaperone to accompany students
  - Transportation to and from Islandwood
  - Meals/snack during road trip to and from Islandwood





# **Local Summer Programs**

- Preliminary summer program allocation to be released first of January (after winter break)
- District invited to apply by end of January
- February release final allocations and grant application
- Application may be submitted March 2022 or afterwards (before end of regular school year)
- May include health supports and services
- Should have an Identification and Recruitment plan
