#### Title: Celebrating Strengths: Empowering Indigenous Students, Staff, and School Communities as Hope Dealers

#### **Description & Rationale**

- Counteracting the typical deficit approach in our lives, communities, and education with the promotion of positivity, strength, optimism, and hope is not merely a lofty ideal but a pragmatic and evidence-based strategy.
- Research shows that focusing on strengths and resilience fosters better mental health outcomes, enhances academic achievement, and builds stronger, more cohesive communities.
- By recognizing and celebrating the inherent strengths and cultural richness of Indigenous communities, we empower individuals to see themselves as capable and valued contributors to society.
- This shift from a deficit-focused narrative to one of hope and possibility can break the cycle of negativity and trauma, leading to tangible improvements in well-being and success.
- Embracing a strength-based approach acknowledges the reality of challenges while equally affirming the power of community, culture, and individual potential to overcome them. By fostering environments where positivity and optimism thrive, we create spaces where all members can flourish and realize their full potential.

STEP 1 - Registration:
