

# *OSPI CNS School Meal Programs Reference Sheet*

## **Verification Summary Report – CEP/Provision 2 District-Wide and RCCIs**

The Verification Summary Report (VSR) must be completed annually by all local education agencies (LEAs) participating in the National School Lunch Program and School Breakfast Program. The report compiles the results of the verification process. When the LEA does not collect free and reduced-price meal applications to determine eligibility for meals, the verification process is not required. However, these LEAs must report enrollment and certify that direct certification was conducted, and verification was not required.

### **Requirements**

- The Verification Summary Report process must be submitted in the Washington Integrated Nutrition System (WINS) by February 1<sup>st</sup> of each year.
- Complete the Verification Summary Report process, described in the *Other Details* section. This process includes:
  - Accessing the Verification Summary Report in WINS.
  - Reviewing and confirming enrollment data.
  - Attesting that direct certification was not required.
  - Attesting that the LEA is exempt from the Verification process.

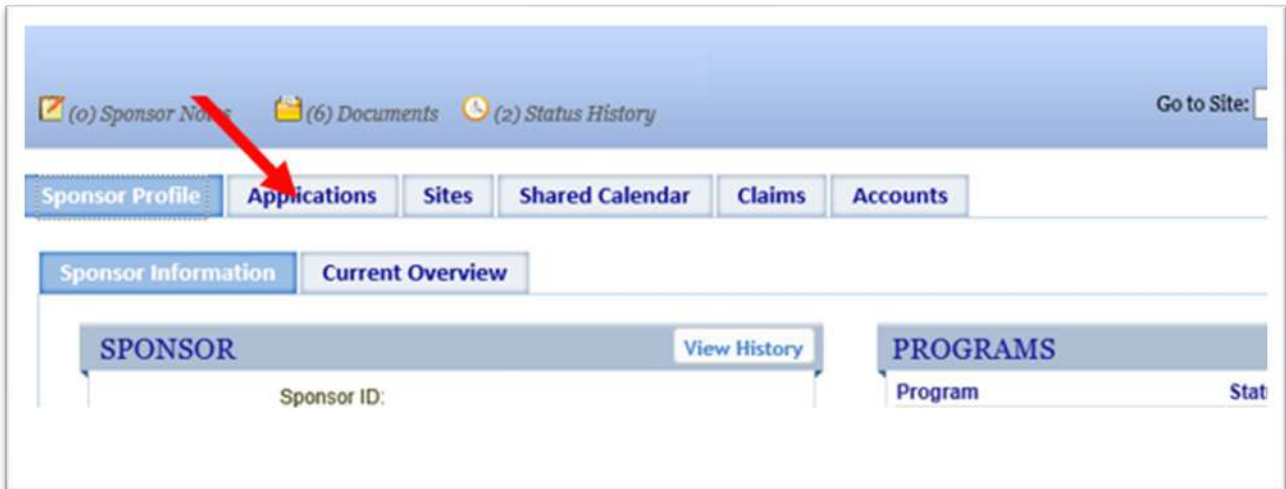
##### **Step 1**

Before accessing the verification summary report in WINS, ensure you have submitted your October claim for reimbursement and October Building Data.



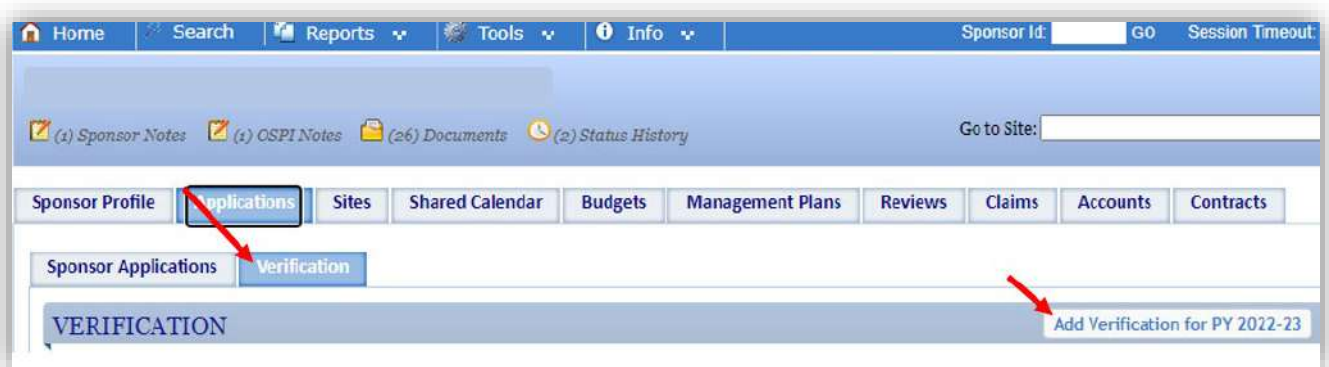
## Step 2

From the sponsor profile page, select the 'Applications' tab.

Select the 'Verification' tab and then "add

- Confirm the data in boxes 1-1A, 1-1B, 2-3A, 2-3B are correct.
  - This information is auto populated from the October claim,
- Attest that all sites are not required to perform direct certification and are exempt from the verification process.
