Summary

So far in this unit, we have looked at crimes and punishments for crimes. Crimes that are committed in a business setting are called white-collar crimes. Yesterday, we introduced a variety of common white collar crimes.

We also looked at some fables yesterday. Fables are stories that teach us some sort of lesson, or have a moral. They often use animals as characters.

Your Task

For this project, you will research a major white-collar crime that has been committed in the United States. Once you have collected enough information, you will turn your crime into a fable to warn others of the risks associated with committing a white-collar crime. In true fable fashion, your story must have animals for characters and a moral at the end. Your fable should include the following information about your crime (insert information into this document, then copy and paste sources at the end):

- Company Name
- Name of Individuals Involved in Crime
- Motive for Committing Crime
- What Crime was Committed
 - What it is called
 - What illegal actions were taking place
- How the Crime was Discovered
- Punishment for the Crime
- Result of Crime (new laws passed, company shuts down, individuals fired, etc.)
- Moral
